This 2017 contract is for breeding to the Friesian stallion Andries 415 Sport, owned by Maddi's Friesian Ranch, LLC. This agreement is valid only for the 2017 breeding season. Mare owner and Maddi's Friesian Ranch LLC agree to the following terms and conditions:

1) Maddi's Friesian Ranch LLC stands the Friesian stallion known as Andries 415 Sport and will breed to KFPS/FHANA registered Friesian mares only. Semen shipped is to be used on only the mare provided in this agreement. This agreement cannot be transferred or sold by the mare owner unless permission is given by Maddi's Friesian Ranch LLC.

2) Maddi's Friesian Ranch LLC breeding season for Andries 415 is from March 14 to September 31, 2017. Cooled semen will be available in the order contracts have been received. Advanced booking will place your mare at the top of the list for shipped semen. All other semen requests will be on a first come basis.

3) In order for semen to be collected and shipped for timely arrival, semen must be ordered the day before the intended insemination and before 10:00 AM Pacific Standard Time.

4) Requests for semen are to be made to the stallion manager by 10:00 am Pacific Time. A message can be left on the cell phone. Messages are checked several times a day. Confirmation of the order of semen will be given via email, text or telephone. Please do not call between 10:00 PM and 6:00 AM Pacific Time.

5) The stallion manager must receive reasonable notice of desired collection and shipment dates. The mare owner is to advise stallion manager upon start of the mare's cycle and contact the stallion manager again the day of the desired collection and shipment. The stallion manager cannot guarantee shipment on the desired date without this information. Semen for Andries 415 Sport can be shipped five days a week (Monday through Friday) in the US.

6) The mare owner will be responsible for all costs involved in collection. Orders cancelled after the stallion has been collected will be billed. Maddi's Friesian Ranch LLC assumes no responsibility for the loss of semen or semen viability caused by the carrier. There will be no shipment on Saturdays, Sundays, holidays or the day before a holiday.

Fees are set up as following:

Breeding Fee – Andries 415 \$1500.00  
Collection/shipping - U.S. \$275.00 per shipment – weekday delivery  
\$325.00 per shipment – Saturday delivery  
(Includes FedEx shipping fees)

Collection/shipping - Canada  
Collections on M-Th

\$475 per shipment includes all fees, including shipping and USDA fees. Please call 1 week before expecting to need a shipment in Canada to allow time for required paperwork. Semen can be ordered the day before needed.

7) If the 2017 pregnancy does not result in a live foal, the Live Foal Guarantee will apply. A “live foal” is considered a foal that has stood and nursed without assistance after being born. If a live foal is not obtained from the 2017 breeding, the mare owner can use Andries 415 for the 2018 breeding season only and for the same mare. No contract fee would be charged, however collection and shipping fees will be charged.

8) The Live Foal Guarantee can be given only when:

- All costs involving breeding have been paid in full at time of breeding.
- Sufficient proof is provided that the mare has been vaccinated against diseases that can cause abortion or damage to the unborn foal (a written statement including vaccines and dates given).

- A written statement is provided, within one week of foaling, from a licensed veterinarian documenting that the foal has been unable to stand and nurse without assistance.

9) Return service privilege for the live foal guarantee must be used in the breeding season subsequent to the date of this contract. If mare specified in this contract does not settle, or a live foal is not obtained, or the mare dies or cannot be used for breeding in the following year after the date of this contract, another Friesian mare may be substituted, subject to our acceptance of the mare.

10) Mare owner shall not be entitled to a refund of fees paid hereunder except if the stallion should die or become unfit for service prior to serving the mare in the present breeding season. Any refund would be subject to a 15% processing fee.

11) Maddi's Friesian Ranch LLC cannot be held responsible in any way for any illness or injury to a mare or to any other horse due to breeding to stallions of this company, nor for a mare's failure to conceive.

12) A Breeding Certificate will be issued by the Friesian Horse Association of North America and will be mailed to the mare owner in the spring of 2018.

13) Mare owner understands that each shipment of semen will contain one dose of semen. A second dose will be included in the shipment only after all orders are filled and additional doses are still available. Priority will be given in the order the contracts were received. To insure your place on the top of the list, we encourage you to return this contract with payment in full early.

14) Mare owner should have their mare checked for pregnancy at approximately 15 days after ovulation. This allows for time to handle any issues around possible twin embryos as well as give the mare owner and Maddi's Friesian Ranch LLC time to prepare for the next breeding cycle if the mare did not settle. It is agreed that mares bred shall be checked for pregnancy by a licensed veterinarian approximately 45 days after the last date of insemination. **Failure to accurately report status of mare in question in a prompt manner could render the live foal guarantee null and void.**

15) This contract cannot be assigned or transferred by the Mare owner. There shall be no right of return to the stallion if the mare is sold or otherwise changes ownership.

16) The laws of the State of Nevada govern this contract. All accounts are payable in U.S. dollars.

17) Mare owner acknowledges full agreement with the above contract by signing and returning this contract to Maddi's Friesian Ranch LLC.

Please fill out all mare and owner information and return this contract to Maddi's Friesian Ranch LLC.

Be sure to make a copy for your records.
